Group 1: Rethinking approaches to promoting the role of women in strengthening peace and stability in the region in light of current challenges:

- What unique aspects of women's leadership are being overlooked?
- Tools, structures, and practices that help overcome challenges and obstacles
- Examples of leveraging women's experience and competencies in contextual knowledge, understanding conflict dynamics, local networks, and other sets of civic skills.
- How can successful stabilization efforts at the local level be expanded to create momentum for positive change at the national and regional levels?

**Group 2**: Gender approaches to climate change adaptation for strengthening community resilience and reducing instability risks:

- What gaps exist in the current understanding or data on the impact of climate change on women?
- How can data collection and analysis be improved to better inform policy and actions?
- What key changes or developments are needed to enhance women's resilience, especially in rural areas, to the longterm effects of climate change?
- Examples of innovative strategies women have used to adapt to a changing climate, particularly in agriculture, water resource management, and household resilience.
